1.1 Overview




Figure 1-1 Overview of Mobile Network Mini Dome Camera

Press **Reset Button** about 10s when the camera is powering on or rebooting to restore the default settings, including the user name, password, IP address, port No., etc.

This camera series has several camera models, each of which may have different cable group. The following figures and tables show the description of all possible cables in this camera series.




Figure 1-2 Cable Overview




Figure 1-3 RJ45 Interface and M12 Aviation Plug

2 Installation

Before you start:

- Make sure the device in the package is in good condition and all the assembly parts are included.
- The standard power supply is 12V DC or 24V AC, please make sure your power supply matches with your camera.
- Make sure all the related equipment is power-off during the installation.
- Check the specification of the products for the installation environment.
- Make sure that the wall is strong enough to withstand four times the weight of the camera and the bracket.

For the camera that supports IR, you are required to pay attention to the following precautions to prevent IR reflection:

- Dust or grease on the dome cover will cause IR reflection.
 Please do not remove the dome cover film until the installation is finished. If there is dust or grease on the dome cover, clean the dome cover with clean soft cloth and isopropyl alcohol.
- Make sure that there is no reflective surface too close to the camera lens. The IR light from the camera may reflect back into the lens causing reflection.
- The foam ring around the lens must be seated flush against the inner surface of the bubble to isolate the lens from the IR LEDS.
 Fasten the dome cover to camera body so that the foam ring and the dome cover are attached seamlessly.

2.1 Memory Card Installation

Camera of this series supports a memory card as the local storage. Follow the following steps to mount the memory card.

Steps:

 Unscrew the dome cover to disassemble the camera with supplied wrench.




Figure 2-1 Disassemble the Camera

2. Insert the memory card into the memory card slot.




Figure 2-2 Install the Memory Card

3. (Optional) To unmount the memory card, push to get it ejected.

2.2 Camera Mounting

Before you start:

- Do not tear off the protection film until the installation is completed.
- . Do not touch the inside face of the bubble with your hands.

Steps:

1. Paste the drill template to the desired mounting place.




Figure 2-3 Drill Template

- 2. Prepare for cable routing.
 - If you want to route cables through the ceiling, cut a hole according to Hole A of the drill template.

If you want to route cable through the side outlet of the mounting base, use a plier to remove the piece of plastic that blocks the side outlet.




Figure 2-4 Clear the Side Outlet

Fix the mounting base with expansion screws or self-tapping screws. If you use expansion screws, drill the screw holes according to the Screw Hole 1 of the drill template, see Figure 2-3.




Figure 2-5 Screw Holes on Mounting Base

2. screw holes for camera




Figure 2-6 Install the Mounting Base

 Route and connect cables. Fix the camera to the mounting base with two PM4×8 screws.



(Optional) For cameras that are installed outdoor, it is recommended to install water-proof jacket to the network interface. See Section 2.3.




Figure 2-7 Fix the Camera

5. Adjust the surveillance angle.




Figure 2-8 3-Axis Adjustment

- 1). View the image via the web browser.
- Slightly loosen the screw beside the RESET button to adjust the surveillance angle.
- Stick the supplied plastic ring in the camera. Hole and move the ring to adjust the panning, tilting, and rotating position to get the desired angle.
- Remove the plastic ring and tighten the hex screw to finish adjustment.
- 6. Install the dome cover back to the camera.




Figure 2-9 Install the Dome Cover

7. Tear off the protection film softly to complete the installation.

2.3 Installation of Network Cable Water-proof Jacket (Optional)

Purpose:

If the camera is installed outdoor, you can adapt the water-proof accessory for the network cable after the camera is secured on the installation surface.




Figure 2-10 Water-proof Accessory Components

Steps:

- Feed the plugless network cable ① through the lock nut ⑥, waterproof rubber gasket ⑤ (the rubber gasket inset ridge must face the waterproof endcap), and the waterproof endcap ④ in order.
- Crimp an RJ-45 network plug (3) onto the end of the cable, taking care to insert the twisted pairs of wires in correct order.
- Place the O-type gasket ② onto the end of the camera's network interface socket ①.
- Insert the network plug (3) into the camera's network interface socket (1).

- Insert the waterproof rubber gasket (§) into the waterproof endcap (4), and secure lock nut (6) with the waterproof endcap (4).
- Align the snap on the waterproof endcap (4) with the notch on the camera's network interface socket (1), and then secure the waterproof endcap (4) to the camera's network interface socket (1) to finish installation.




Figure 2-11 Water-proof Accessory Installation

3 Setting the Network Camera over the LAN

Note:

3.1 Wiring

Please connect to the camera to the network according to the following figures




Figure 3-2 Connecting via a Switch or a Router

3.2 Activating the Camera

You are required to activate the camera first by setting a strong password for it before you can use the camera.

Activation via Web Browser, Activation via SADP, and Activation via Client Software are all supported. We will take activation via SADP software and Activation via Web Browser as examples to introduce the camera activation. Please refer to the User Manual of Network Camera for Activation via Client Software.

3.2.1 Activation via Web Browser

Steps:

- Power on the camera, and connect the camera to the network.
- Input the IP address into the address bar of the web browser, and click Enter to enter the activation interface.

Notes:

- The default IP address of the camera is 192.168.1.64.
- For the camera enables the DHCP by default, the IP address is allocated automatically, and you need to activate the camera via SADP software and search the IP address

3. Create a password and input the password into the password field.



STRONG PASSWORD RECOMMENDED— We highly recommend you create a strong password of your own choosing (using a minimum of 8 characters, including at least three of the following categories: upper case letters, lower case letters, numbers, and special characters) in order to increase the security of your product. And we recommend you reset your password regularly, especially in the high security system, resetting the password monthly or weekly can better protect your product.

- 4. Confirm the password.
- 5. Click **OK** to save the password and enter the live view interface.

3.2.2 Activation via SADP Software

SADP software is used for detecting the online device, activating the camera, and resetting the password.

Get the SADP software from the supplied disk or the official website, and install the SADP according to the prompts. Follow the steps to activate the camera, please refer to the User Manual of Network Camera for other two activation methods.

Steps:

- Run the SADP software to search the online devices.
- Check the device status from the device list, and select the inactive device.

Note:

The SADP software supports activating the camera in batch. Please refer to the user manual of SADP software for details.

Create a password and input the password in the password field, and confirm the password.

And we recommend you reset your password regularly, especially in the high security system, resetting the password monthly or weekly can better protect your product.

4. Click OK to save the password.

You can check whether the activation is completed on the popup window. If activation failed, please make sure that the password meets the requirement and try again.

3.3 Modifying the IP Address

Purpose:

To view and configure the camera via LAN (Local Area Network), you need to connect the network camera in the same subnet with your PC. Then, install the SADP software or client software to search and change the IP of network camera. We will take modifying the IP Address via SADP software as an example to introduce the IP address modification.

Steps:

- 1. Run the SADP software.
- Select an active device.

Note:

Please refer to Section 3.2 to activate the camera if the camera is inactive

Change the device IP address to the same subnet with your computer by either modifying the IP address manually or checking the checkbox of Enable DHCP.

4. Input the password to activate your IP address modification.

The batch IP address modification is supported by the SADP; please refer to the User Manual of SADP for details.

4 Accessing via Web Browser

System Requirement:

Operating System: Microsoft Windows XP SP1 and above version

CPU: 2.0 GHz or higher

RAM: 1G or higher

Display: 1024×768 resolution or higher

Web Browser: Internet Explorer 8.0 and above version, Apple Safari 5.0.2 and above version, Mozilla Firefox 5.0 and above version and Google Chrome 18 and above version

Steps:

- 1. Open the web browser.
- In the browser address bar, input the IP address of the network camera, and press the Enter key to enter the login interface.

Note:

- The default IP address is 192.168.1.64.
- If the camera is not activated, please activate the camera first according to Section 3.2.
- Input the user name and password.

The admin user should configure the device accounts and user/operator permissions properly. Delete the unnecessary accounts and user/operator permissions.

Note:

The IP address gets locked if the admin user performs 7 failed password attempts (5 attempts for the user/operator).

4. Click Login.

Install the plug-in before viewing the live video and managing the camera. Please follow the installation prompts to install the plug-in.

Note:

You may have to close the web browser to finish the plug-in installation

Reopen the web browser after the installation of the plug-in and repeat steps 2 to 4 to login.
